HOTEL EMPLOYEE ACCEPTANCE ASSESSMENT SYSTEM WITH ANDROID-BASED MOORA METHOD

Abstract

Hotel is a company engaged in the field of services, which requires employees who have competencies in accordance with their fields. At present the existing employees are deemed to lack competency in accordance with their field of work. In order for employees to have competence according to their field of work, the hotel must carry out an acceptance assessment that requires certain criteria, such as education, foreign language acquisition, discipline, experience and others. One of the appropriate decision making methods for evaluating acceptance is the MOORA (Multi Objective Optimization on the basis of Ratio Analysis) method which is a multi-objective system that optimizes two or more conflicting criteria. The MOORA method has a degree of flexibility and ease of understanding in separating the subjective parts of an evaluation process into criteria, by determining the weights and attributes as decision making, the form of decision matrices and ranking. The criteria used in this study are height, experience, discipline, interviews, written tests, languages, friendly, computer, software and medical checkups. To facilitate the assessment of acceptance, this system is applied based on Android, so that in addition to the hotel, prospective employees can also find out the results of the assessment. Based on the implementation of the system application, the use of the MOORA method for the hotel employee acceptance evaluation system can produce the right decision system, in accordance with the predetermined ranking, criteria and weight of the assessment.

1. Introduction

Every person is facilitated by the development of information and communication technology at this time, both to carry out communication, find every important activity, and play music or watch videos on a mobile phone. The use of mobile phone Technology, will make it easier for someone to get information about job vacancies desired, where information can be obtained through electronic print media, such as newspapers, magazines,

brochures or information from social media. Employee acceptance and assessment, as in other aspects of business today, depends on speed and accuracy. The more applicants who meet the requirements according to the existing field of work, the leadership needs to find ways to determine the application quickly, accurately in selecting the best candidates [1]. This can be seen and assessed from the criteria set by the company for the process of receiving prospective employees, which of course differs according to the job function

required [2]. The number of applicants who submit job applications in accordance with the vacancies that have been spread by the Hotel, it must be assessed by each applicant, which requires long time a and is thoroughness. This because the assessment is still done manually in the form of answers on a sheet of paper and sums up all values adjusted to the specified criteria. Another problem is the lack of acceptance in accordance with competencies and occupations, which is caused by the inaccuracy of the assessment system used for the acceptance of its employees. Based on this, a solution is needed to overcome this, namely the use of an appropriate application system to be able to assess employee acceptance according to the expected competency requirements based on predetermined criteria and weights. One of the appropriate methods to overcome this problem is the MOORA (Multi-Objective Optimization on the basis of Ratio Analysis) method, as a method for providing priority recommendations for receiving employees needed by the company [3]. The advantage of using the MOORA method is that it has a good degree of flexibility and selectivity because it can determine the objectives of conflicting criteria that are more accurate and precise in helping decision making for each individual [4]. However, there are many potential individual differences such as personality traits and cognitive abilities that can predict employee acceptance assessment results [5].

previous research conducted by [6], that the MOORA (Multi Objective Optimization on the basis of Ratio Analysis) Method was first proposed by Brauers and Zavadkas by considering useful and not useful goals (criteria) for determining rankings or selecting one or more alternative to the set of options available. Decisions made can be effective and better. The use of the MOORA method can be used as part of a decision support system that contains simple calculations and only requires some physical

data from the field. This study discusses the analysis for selecting teaching assistants who work in laboratory computers based on several assessment criteria [7]. Then [8] states the growth and development of a company depends on its ability to recruit and choose high-quality personnel at all levels in each section by conducting a proper acceptance assessment. Next the employee acceptance assessment starts with a clear statement of the company's objectives based on the type of knowledge, skills, abilities and other characteristics.

From the research that has been done more focused on the use of the MOORA method as an analysis to help decisionmaking related to acceptance, employee evaluations based only on criteria, and the absence of the use of applications for their implementation. This research discusses the assessment of employee acceptance using the Android-based MOORA method. The final result of this study is an application system for hotel employee acceptance evaluation with the Android-based MOORA method. The use of this system application can assist hotel management in determining employee recruitment in accordance with the requirements, attributes and weights and competencies that are appropriate in their fields more effectively, according to the ranking by the system.

2. Research method




Figure 1. Stages of research methods

The research method used in the study of hotel employee recruitment assessment systems using the Android-based MOORA method, was carried out through several stages. The stages of the study are explained in the form of data collection, MOORA methods, system analysis and design, system implementation and conclusions. Research stages, can be seen in Figure 1.

Data collection in conducting this research was carried out using several methods:

- 1. Observation, were made at the Fox Harris Hotel Pekanbaru City branch located on Jalan Riau No.147, Kampung Baru, Senapelan District, Pekanbaru City, Riau Postal Code 28154.
- 2. Interviews, interviews are conducted to get data that suits the needs of the system. The interview was made to ask a number of questions related to the employee recruitment assessment system, the system used, job vacancy criteria, other terms and conditions. Interviews were conducted with five applicants and HRD Hotel Manager.

3. Litareture Review

Literature review is conducted to obtain appropriate data and information as a reference in conducting research. The literature review used in conducting this research includes the following:

- 1. Assessment system, Every company (organization) will always focus on the employee appraisal process, at the beginning of the reception and on the process in progress. The assessment is based on a number of criteria and prepared questions [9]. Assessment can be for your self, the assessment of the company and the assessment of colleagues. A good appraisal system provides accurate results and will encourage companies to be more advanced and developed.
- 2. Employees, are vital resources for almost all companies, mainly because they represent a significant investment in terms of placement, recruitment, health services, bonuses and others [10]. The management of many companies develops their employees in several trainings as a form of long-term career development.
- 3. MOORA, is a multi-objective system that optimizes conflicting attributes

simultaneously. Namely, the criteria that are worth or benefit and which are not worth or cost. The MOORA method was first used by Brauers in 2004 and introduced in 2006 by Zavadkas and Brauers [11]. in the MOORA method is divided into several stages to carry out the process, until finally the maximum value is obtained.

The MOORA method has a degree of flexibility and ease to understand in separating the subjective parts of an evaluation process into decision weight criteria with several attributes of decision making [12]. This method has a good level of selectivity because it can determine the objectives of conflicting criteria. The steps to solve the problem using the MOORA method as follows

1. Determine the normalization matrix, representing all the information available for each attribute in the form of a decision matrix, using the formula:

- b. i: 1,2,3, ... n is the order number of the attribute or criterion
- c. j: 1,2,3, ... n are alternative sequence numbers

x: Decision matrix

2. Normalize the X matrix using the formula

3. Optimizing Attributes

For Multi objective optimization, the normalized measure is added in the case of maximization (for the beneficial attribute) and subtracted by the minimization case (for the unfavorable attribute), by formula

- a. i: 1,2,3, ... n is the order number of attributes or criteria with maximized status
- b. j: g + 1, g + 2, g + 3, ... n are attributes or criteria with minimized status
- c. y_j ^ *: Alternative max-min Normalization Matrix j

Where g is the number of attributes to be maximized, (n-g) is the number of attributes that will be minimized and yi is the normalized value of alternative 1 for all attributes. When the weight attribute is considered, equation 3 becomes as follows.

Explanation:

- a. i: 1,2,3, ... n is the order number of attributes or criteria with maximized status
- b. Wj: Weight of alternatives
- c. j: g + 1, g + 2, g + 3, ... n are attributes or criteria with minimized status
- d. y_j ^ *: Alternative max-min normalization matrix j for all attributes next to Rank Y, where Yi values can be positive or negative depending on the maximum and minimum totals in the decision matrix. The ranking order and Yi indicate last resort. The best alternative has a high Yi value, while the bad alternative has a low value.
- 4. Android, is a mobile device that is currently used more than desktops / PCs, with around 72% oof all computer device owners in Indonesia using mobile devices. Mobile device applications with the Android operating system can facilitate the transfer of interactive and practical information anywhere and anytime [13]. This

- research application uses Android studio for IDE (Integrated Development Environment) official for Android application development and is open source or free. Since then, Android Studio has replaced Eclipse as the official IDE for developing Android applications
- Unified Modeling Language (UML), is a diagram of interaction very relevant in system design activities as the various interaction between the components involved. The steps of using UML diagrams by explaining the behavior or structure either statically or dynamically by using several diagram models, such as use case diagrams, activity diagrams, sequent diagrams, class diagram and others [14].

4. System Analisys and Design

4.1 System Application




Figure 2. The proposed application system

The description proposed by the admin can do the data processing of new job input data or see applicants who register the vacancy. Applicants can also see detailed information from the vacancy information and requirements that have been inputted or determined by the admin. In application, the system will send data and then the data will be converted into JSON (Java Script Object Notation) form before the data is sent to the server and stored in a database. To get data from the database data requested by the application will first be converted into JSON and then converted into data that can be read by android. The following picture of the system to be proposed can be seen in Figure 2

The application system is complemented by the MOORA method that will assist the HRD in ranking rangking based on the criteria and weight of the results of the calculation of the assessment carried out, as a recommendation to HRD in making decisions or determining suitable candidates for employment.

4.2 Assessment criteria

In applying the MOORA method for recommendations on evaluating employee acceptance, there are several things that need to be done beforehand, namely:

1. Identification of criteria

in this study there are 10 criteria that will be used for the calculation of assessment, namely: C1=Height, C_2 = Diving, C_3 = Friendly, C_4 = Discipline, C_5 = Medical Check, T_1 = Written test, T_2 = Interview, T_3 = Interview Software, T_4 = Foreign Language, T_5 = Computer

Here are the criteria for the criteria and their weights:

4.3 System Design

Use case diagram is a system behavior in response to an action or request from outside the system. The following is the use case diagram modeling in the application system.




Figure 3. Use case diagram




Figure 4. Activity diagram of employee value




Figure 5. Activity diagram entering the results of the selection

3.3 Interface design

Interface design is the design of the interface of an application that focuses on system users when using the application. There are two stages in interface design, namely input and output design. input design is a display that users use to interface with the application system.

a. Input design




Figure 6. Design of mobile telephone numbers

For the input design is the beginning of the user process with the system in the form of data input into the system, which can be seen in Figure 6 below:




Figure 7. Design verification of OTP receipt




Figure 9. Design assessment input

Output design is a place to display data from input design. in the draft output can provide a report, how the input has been given. The output design of the employee assessment system can be seen in the following design:




Figure 10. Design of main page application system output




Figure 11. Design output report recapitulation report system results




Figure 12. New user account employees After registration by the user, in order to enter the OTP code that has been received by the employee as verification process for the application system user. OTP code display results as shown in Figure 13 below:
